Landscaping Services

Introduction

The fiduciary procedure for securing quotes follows CRT's Request for Quotation guidelines. Local firms found available for the work, including those with a work history with CRT, are contacted for work detail and cost statements.

Scope of Work

CRT is looking to obtain quotes from landscaping companies to provide landscaping services at fourteen (14) of our properties, Scope of Work includes the following:

- Weekly Services mowing/weed whacking/weeding (weeding mulched areas, walkways, parking lots around the site) to being in June- unless otherwise communicated by CRT Contact)
- Hedge/tree trimming ground level (as needed)
- Mulching (at selected locations contractor to remove existing mulch install weed barrier fabric and new mulch);
- Planting flowers at the entrance and in flowerpots (555 Windsor Street ONLY) Flowers at entrance and pots to be changed by season Spring, Summer and Fall (total 6 large flowerpots provided – contractor to provide flowers and soil)
- Spring cleanup (one time);
- Fall cleanup (Final Service may require multiple visits billable as one service);
- A schedule of lawn services must be presented and approved by CRT Contact.
- Contract term April 2025 November 2026 with the option to extend with the approval by both parties.

In addition, we would be looking for the contractor to make recommendations (outside of the contract scope of work) to keep our properties looking well maintained and aesthetically pleasing. (ex: overgrown bushes that are not CRT property, but coming over on our property are is needed to clean up this area. Contact CRT contact and submit a quote as this would be outside the contract scope of work)
